

#### Bid Submission Instructions (3)



- 4. Check your bid form for any errors, which will be flagged in red. Possible errors can include:
  - Too many blocks for a single Product are entered. Each Product is limited to the number of blocks shown in the column headers. If this error is not fixed, the blocks with the highest prices will be eliminated until the max number of blocks is reached.
  - The number of blocks bid at each price must be an integer. If a non-integer number of blocks is bid, the fractional block will be eliminated.
  - A price less than \$1.00/MWh or greater than \$1,000/MWh is bid.
     Blocks with prices outside this range will be assumed to be in error and will not be evaluated.
  - If no price or no number of blocks is entered in a row, that row is interpreted as a "no bid" and ignored. This also applies to any row where the number of blocks entered is ≤0

#### Examples of Bid Form Errors (2)



- Too many blocks are entered, one of the \$15 bids will be eliminated
- 2. A non-integer number of bids is entered, the number of blocks bid at \$20 will be rounded down to 5
- 3. No number of blocks is entered for the \$10 bid, therefore only the 5 blocks each at \$20, \$30 and \$40 will be evaluated
- 4. The \$2,050 bid is above the maximum price, therefore this bid will not be evaluated
- 5. The \$0.25 bid is below the minimum price, therefore this bid will not be evaluated
- 6. No price is entered for the first bid, therefore this bid will not be evaluated

- 5. After all errors are corrected, save the file. The default name will be EnergyBidForm1.xls, but you can add your company name or bidder number to the file if you wish please do not use any special characters in the file name, as this may impair the evaluation process
- On the Bidder Registration page, click on "Submit Bid" which will open a new window



◆ Final binding bids must be submitted by 12:00 noon,
 CPT on Tuesday, May 5<sup>th</sup>

 Bids will only be evaluated if Pre-Bid Letter of Credit and Bidder Registration Form have been received by 5:00 CPT on Monday, May 4th

### Supplier Fee

#### Supplier Fee



- Supplier Fee preliminarily estimated to be \$0.04/MWh from each Winning Bidder
- Will be paid as part of the settlement statement for each Product
- Separate email will go out to all bidders with information about the final Supplier Fee by Monday, May 4th



#### **Bid Evaluation**

#### Bid Evaluation



- Because there are no contingent or linked bids, bid evaluation is very straightforward
- ◆ After checking each bid for errors, the bids for each product are sorted by price, and the lowest-priced X 50-MW blocks for each product are selected, subject to price benchmarks, where X is the number of blocks for that product (as shown in the RFP and on the Bid Form)

#### What Happens In Case of a Tie?



◆ If there are two or more blocks at the price (rounded to \$0.01/MWh) that clear the Product quantity requirement, the Procurement Administrator will select the required number of blocks at the clearing price in order to maximize the number of bidders in the award group



#### **Bidder Notification**

#### Schedule Following Bid Submission



- Procurement Administrator submits report with recommended winning bidders to ICC on Wednesday, May 6<sup>th</sup>
- ◆ ICC decision by Friday, May 8<sup>th</sup>
  - Special meetings to discuss the procurement results scheduled for 10:30 am CPT on Thursday, May 7<sup>th</sup> and Friday, May 8<sup>th</sup>
- Winning Bidders notified following ICC decision
- Contracts executed with Winning Bidders within three business days of ICC decision
  - ICC decision on May 7<sup>th</sup> → Contracts executed by May 12<sup>th</sup>
  - ICC decision on May 8<sup>th</sup> → Contracts executed by May 13<sup>th</sup>
